



2020-2021 GRADUATE SCHOOL TUITION & FEES

APPLICATION

At the time of **application** for entrance to Seattle Bible College, there is a non-refundable application fee of **\$75.00** required. For F-1 **international students there is a \$95.00 application fee and a \$100.00 processing fee** (non-refundable).

TUITION/FEES/TEXTBOOKS

Tuition: \$228 per credit.

Graduate full-time status is **eight credits per quarter: \$1820**

Additional credits (above 8 credits) will be charged at the per credit rate: \$228

A Registration Fee: \$50.00 per quarter

A Technology Fee: \$50.00 per quarter

A Graduate Studies Fee (GSF): \$50.00 per quarter course fee

Auditing Courses: \$100.00 for one class per quarter. Any additional courses will be charged at \$100 per credit hour to audit.

Extension Fee: \$150.00 for two-week extension. *Dean Approval Required.*

Late Fee: \$30.00, for payment 30 days late; **\$60.00**, for payment 60 days late

There will be an additional charge for **textbooks, course notes and/or lab fees**, which will vary in cost from quarter to quarter. Students are to be prepared to pay for all textbook-related expenses for the quarter before attending classes.

SPECIAL RATES

In-service Clergy: \$180.00 per credit for qualified members of the clergy whose main financial support is gained from serving vocationally in ministry (e.g. those ministers who are engaged in at least 20 hrs. per week of Christian service). Students must provide vocational documentation and be approved to receive the discounted tuition rate.

Qualifying F-1 students must be engaged in at least 20 hrs. per week in a non-paid position.

Spousal: \$100.00 per credit for spouses enrolled in the same course as their spouse. The spousal rate for auditing the same course is **\$50.00** per audit hour.

MISCELLANEOUS

Deferred Payment Fee: A deferred tuition plan *may* be available to approved students. If so, a **\$50.00** processing fee will be charged to all students not paying their total quarterly bill for tuition and fees on or before *final registration* day for that quarter. The fee will be charged for each deferred payment plan approved by the student per quarter over the course of the school year. *F-1 International Visa students must make full payment for tuition & fees in advance of the beginning of the initial quarter.* Contact the school office for details.

Graduation Fee: \$250.00 fee is charged for each student graduating from Cross-National Graduate School of Leadership (whether present for the graduation ceremony or not).

NOTE: All fees are non-refundable.

Graduate School Tuition & Fee Overview **2020-2021 Academic year**

The regular academic school year operates on a quarterly system of three quarters per year. Programs consist of fall, winter, and spring quarters. Electives are offered in the summer quarter.
